Bullying Prevention 101

A quick guide for middle and high school students

WHAT IS BULLYING?

Bullying definitions typically include:

- The target is being hurt or harmed by unwanted words or behavior
- The hurtful behavior is repeated or there is a concern that it will be repeated
- The target being hurt has a hard time stopping or preventing the unwanted behavior
- The hurtful behavior is carried out by those who have more (real or perceived)
 power, which is used to control or harm others. Power can mean students who
 are older, are physically stronger, have access to embarrassing information, have
 more social status, or are part of a group that is singling out an individual.

Note: This is not a legal definition, but rather a way to help understand and identify bullying. For your school's definition, check the district's bullying prevention policies. For a legal definition, consult your state's law on bullying at StopBullying.gov.

CAN SOMEONE BE INVOLVED IN MORE THAN ONE ROLE?

YES! It's often the case that the person being bullied, the person doing the bullying, and the person witnessing bullying are not distinct parts! It's more common that students play multiple roles throughout the day.

YOU HAVE RIGHTS

It is important for you to know that there is legislation in every state designed to protect students in a bullying situation. These laws vary from state to state, but many express that:

- Students who are bullied should be provided with support and strategies designed to keep them safe and prevent further bullying
- Those who are bullying should be given consequences that are appropriate for the situation and circumstances
- Students who witness bullying should be trained on how to respond to bullying and the role they can play in creating a safe school community



WHAT YOU CAN DO IF YOU ARE BEING BULLIED OR SEE BULLYING

If you witness bullying, you have the power to stop it. How? Advocacy skills! Learning advocacy skills can help address bullying for yourself and others.

ADVOCACY



Helping others get what they need

SELF-ADVOCACY



Communicating and taking action to get what you need

Advocacy skills can empower you to:

- Involve others, especially adults such as parents or teachers
- Gain confidence to take action to stop the bullying and recognize that you have the right to be safe
- Identify what help you need and think of ways you can respond when bullying happens
- Make choices that lead to positive change for you and the bullying situation

If you are being bullied, it's important to tell someone, especially an adult, you trust. Know that:

- No one ever deserves to be bullied
- You have the right to ask for help to stop the behavior
- Your opinion about what to do is important
- You don't have to go through the bullying experience alone

If you see bullying, you can:

- Help the person being bullied get away from the situation
- Change the subject when your peers start tearing someone down
- Say something positive about the person being bullied
- Take the direct route and, if you feel safe, ask the person doing the bullying to stop
- Find an adult who can quickly intervene

If you see cyberbullying, you can:

- Write something positive in response
- Contact the person being bullied and let them know you are there for them
- Take a screenshot of the bullying, report it to a parent or an adult at school
- Report the bullying content to the social media platform and ask to have it removed

STUDENT ACTION PLAN

Ready to take action to address bullying?

Bullying can be prevented with students, parents, and educators working together to take action. This plan is an opportunity for you—along with your parents or teachers—to develop a strategy to change what's happening to you or someone else.

PACER's Student Action Plan includes three steps:

- Step 1: Describe the bullying. Include dates, location, who is involved, and details of the behavior.
- Step 2: Describe what you would like done. Think about how the situation could be stopped or prevented.
- Step 3: What steps can you take to make that happen? Include who could help, and what they and you can do.

Bullying Prevention 101

A quick guide for elementary school students

WHAT IS BULLYING?

Bullying is when someone:


- is hurt by unwanted words or actions,
- usually more than once, and
- has a hard time stopping what is happening to them.



Bullying can happen anywhere, anytime. It can occur in your neighborhood, on your way to and from school, at school, and while online.

WHAT IS CYBERBULLYING?

Using technology, such as email, texts, social media, online gaming, or pictures to hurt or harm someone else with unwanted, aggressive, and repeated behavior.



WHO IS INVOLVED?

TARGET



Person who is being bullied

Note: "Person" may mean one individual or a group of people.

A person can have more than just one role! The role that any student plays in a bullying situation can change.

DID YOU KNOW...

...there is not just one kind of person who bullies It's not about how someone looks; it's about their actions.

...that a disagreement is different than bullying

A disagreement or argument is when both sides express their views. People don't always agree, and can be in "conflict" when they respectfully share their opposing views without putting down the other person.

...that someone you thought was a friend could be bullying you

If a friend is treating you in a way that hurts you and you have asked that friend to stop but they still continue, that is not friendship. That behavior could be bullying.

...there is a big difference between telling and tattling

A lot of kids say that they don't want to tell an adult about bullying because they don't want to be called a tattle-tale. Telling is done to protect yourself or another student from getting hurt. Tattling is done to get someone in trouble.

...your school probably has a policy against bullying

Every state in the nation has a law that prevents bullying in schools. If you don't know yours, ask an adult at your school about it.

WHAT CAN YOU DO IF YOU ARE BEING BULLIED?

If you are being bullied, the first thing you should know is that it's not your fault.


Nope. Not one bit. No one deserves to be bullied... EVER! There's a lot you can do:

- Know that you do not deserve what is happening
- Tell someone: a parent, teacher, or trusted adult
- Develop a plan, with the help of an adult, about how you can respond to the situation
- Decide—with the help of an adult—how other students might help



If you see someone being bullied:

- Speak Up! You should tell an adult. Telling is not tattling. It's okay to tell an adult when you see bullying or are being bullied. In fact, it's a really smart thing to do!
- Reach Out! Tell the kid who is being bullied that they don't deserve to be treated that way. Nobody does.
- Be a Friend! Let others know that you don't accept bullying at your school, and others will be more willing to speak up, too. Ask friends to join you in being a kid against bullying.

- PARENT CONFERENCE: A required Parent meeting with the instructor and/or the School Administrator.
- DETENTION (C.C.R. TITLE 5, SEC. 353) / COMMUNITY SERVICE (48900.6): A student may be required to attend
 detention during school hours or afterschool or may be required to perform community service during school hours or
 afterschool.
- BEHAVIOR CONTRACT: A Contract entered into between the School, the Student, and the Student's Parent. The Contract outlines the expected behaviors of the student to ensure a positive learning experience and to be allowed to continue enrollment at the school. Required Counseling as part of the contract.
- PARENT ATTENDANCE AT SCHOOL (48900.1d EC): Upon written notice of the school, a Parent shall attend class
 on the day in which the student is scheduled to return from suspension.
- SUSPENSION (48900 EC): A suspension is removal from school for up to 5 days at a time. The suspension is
 appropriate for violations of Education Code 4899. Suspensions are formal, legal documentations and may be imposed
 for up to 20 days in one school year. Parent notification is required for all suspensions. A Parent Conference may be
 required by the school prior to the student being readmitted to class. Counseling may also be required.
- EXPULSION: Expulsion is the removal of a student from the school district for up to one year for serious or continued violations of Education Code.

For the Comprehensive School Safety Plan, it was noted that it had not been approved/updated/reviewed before the March 1st deadline per the audit guide. Because of this, it'll be a state compliance finding and will need to notify the CDE prior to Oct 15th of the noncompliance. Another issue we had noted was for a few cash receipt samples, it appeared that they had been deposited almost over a month and a half after collection. It's recommended that the collections be deposited within a month time. Other than those two, everything was great.
